SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

8.2 Exposure controls

Appropriate engineering controls:

Avoid contact with skin, eyes and mucous membranes. Ensure adequate ventilation. Always observe good personal hygiene measures, such as washing after handling the material and before eating, drinking, and/or smoking.
